Chapter 5 - The World of Slavery and Voluntary Servitude - Did you Volunteer? Are you NOT HAPPY?

"The rich ruleth over the poor, and the borrower is servant to the lender." - Proverbs 22:7.

"...and thou shalt not borrow." - Duet. 28:12.

"The wicked have drawn out the sword, and have bent their bow, to cast down the poor and needy, and to slay such as be of upright conversation." - Psalms 37:14.

A) "Neither slavery nor <u>involuntary</u> servitude,..." - Amend. XIII, United States Constition.

Did you know that you volunteered? Did you know that approx. 99.9% of the individuals of the United States of America volunteered? How is(was) this possible? Did your high school teacher of civics teach you about this? Does your preacher teach you about this? IF NOT, WHY NOT?
