- 3) Reliance on others to institute a 'political reform' can only delay your effective 'faith and work'. Return to THE FATHER'S LAWS!!!



'CONSTRUCTIVE NOTICE AND REQUIREMENT TO PERFORM'

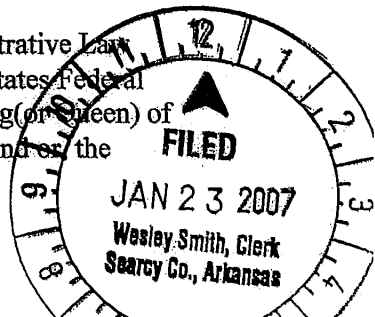
In the Sovereign's land of Searcy County, Arkansas the State, the United States of America, the Republic thereof, Non-Commercial, Non-Corporate, and Non-Federal, as it does apply to Jerry F. 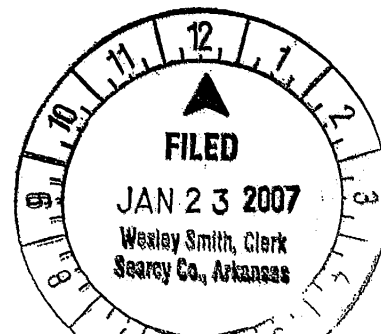

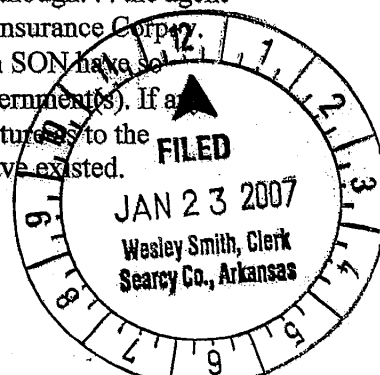

FURTHER be it noticed:

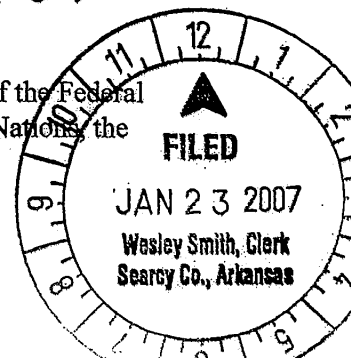

- 3) Provide evidence of your authority to make a presentment, and what Territorial Application (U.C.C. 1-105) exists that we have agreed upon, which contains my signature.
- 4) Since I have declared, exhibited, and affirmed the status of 'nonresident alien' and am not a 'person' as described in 26 U.S.C. - 7343, please provide (as in you are required) me with the copy of the source of income and from that 'geographical part' of the statutorily defined 'United States' you purport it came from in order to substantiate your claim based on agreement.
