With all due respect and courtesy/you are notified and required to correct the following errors on a 'Certificate of Title', Title #99899805997. You are advised that all of these errors were done at the insistance of your employees, programs, and policies. Itsupplied correct information.

ERRORS:

- My name is spelled wrong. I do not use all upper-case letters to describe my name or rights.
- 2) My address is wrong.
- 3) I do not own a vehicle and therefore can not have avehicle vehicle identification number.
- 4) I do not own any personal property as I am not a 'person'.

CORRECTIONS:

- 1) For all documents and legal purposes, my name is Jerry F. Kirk, <u>Sui Juris</u>: exactly.
- 2) My address for receiving 'post' of all documents and or legal notifications, etc. is as exactly above on this letter.
- 3) I own a 'private conveyance' with a chassis identification #E24AHCD5732
- 4) The requirement for 'persons' to do something is not applicable and I do not 'volunteer' to do the 'things' that 'persons' do.

Your failure to make the above corrections will cause a 'fraud' to occur by your agency which will do various damages to me. These corrections need to be completed prior to 11/30/98.

Dear Sir:

This is in response to your letter of November 21, 1998 requesting error corrections on the Arkansas certificate of title for the vehicle above. The type corrections you request are not errors, but the manner in which the motor vehicle system operates. Therefore, with the exception of adding "SUI JURIS" in upper case print, we cannot make the changes you request and following is an explanation as to why:

1. Your title was issued in the same name as reflected on the Florida Certificate of Title and the Security Agreement in favor of Affordable Bail Bonds. However, if the title can be returned to the address above, we will issue a new title with "SUI JURIS" in upper case print, not underlined, following your name.

As to your name being printed in all upper case letters, our computer system is designed for printing in upper case only. Therefore, all information is printed in upper case.

- 2. The address cannot be printed as you request because of space limitations. The name and address area on the title is simply not large enough to accommodate the information as reflected on your letterhead.
- 3. The legal description contained in Arkansas Code Annotated 27-14-207 describes what you call your 'private conveyance' as a vehicle. Therefore, vehicle is used on the title and is used to refer the identification number.
- 4. Not applicable to the printing of a certificate of title.
