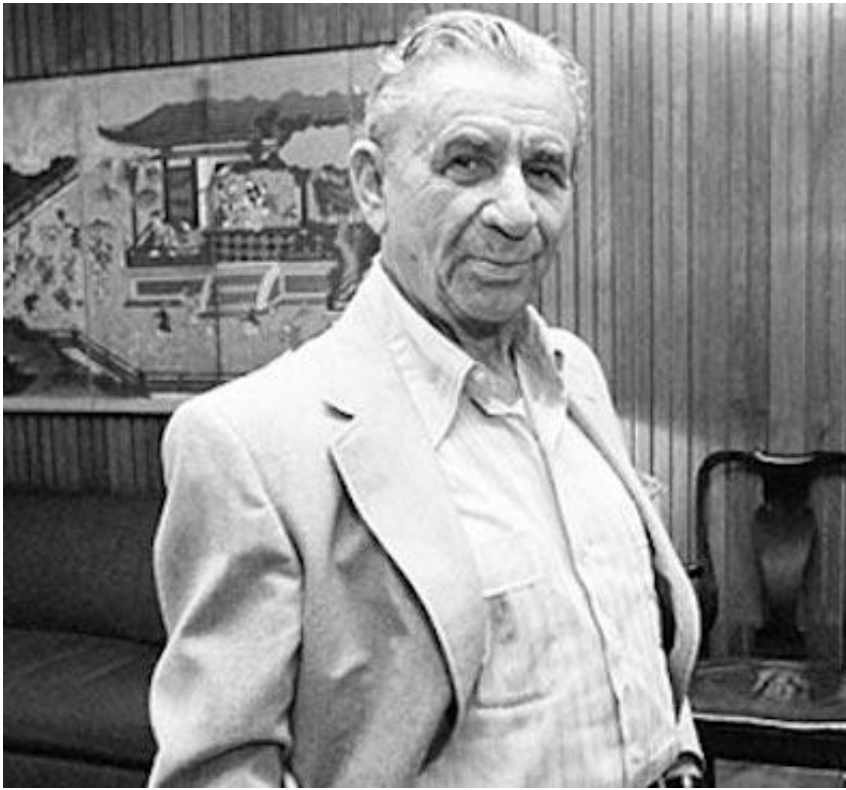

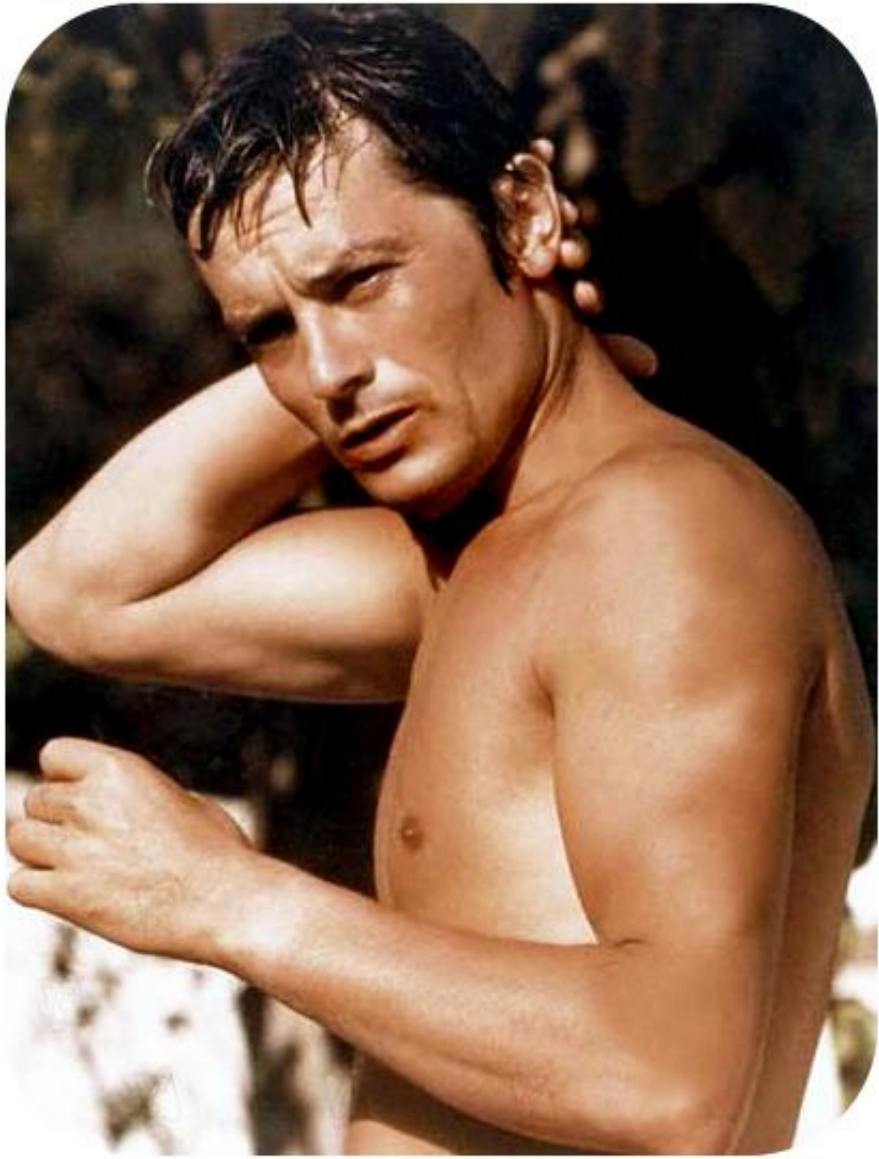

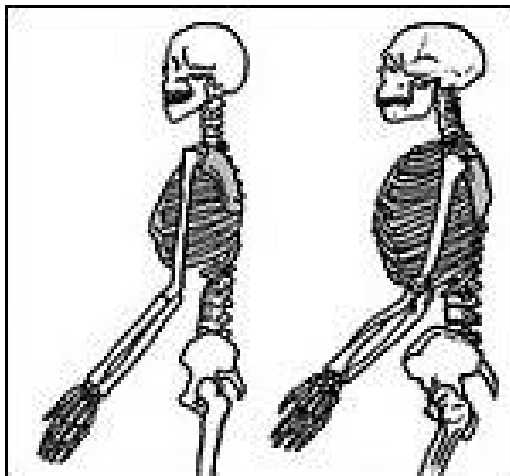

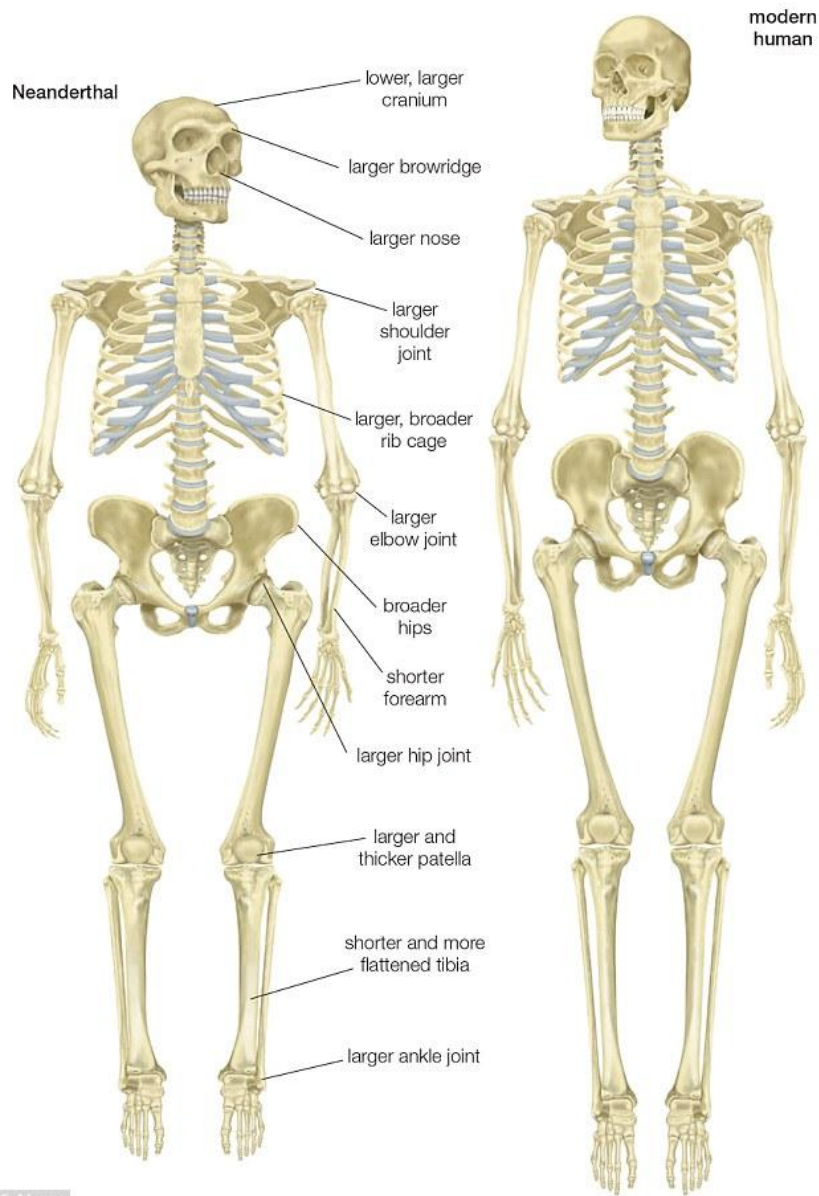

Cro magnon (white) and neanderthal (Jewish) skeletons

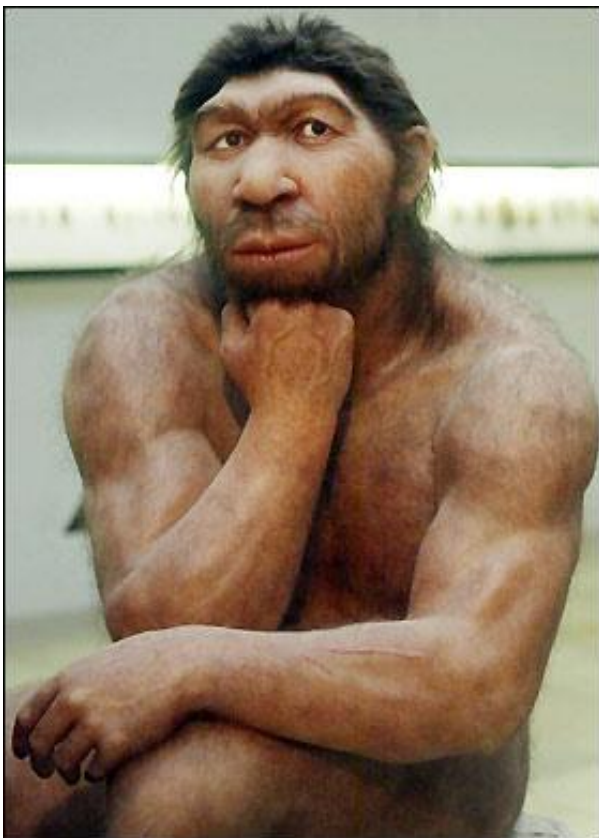

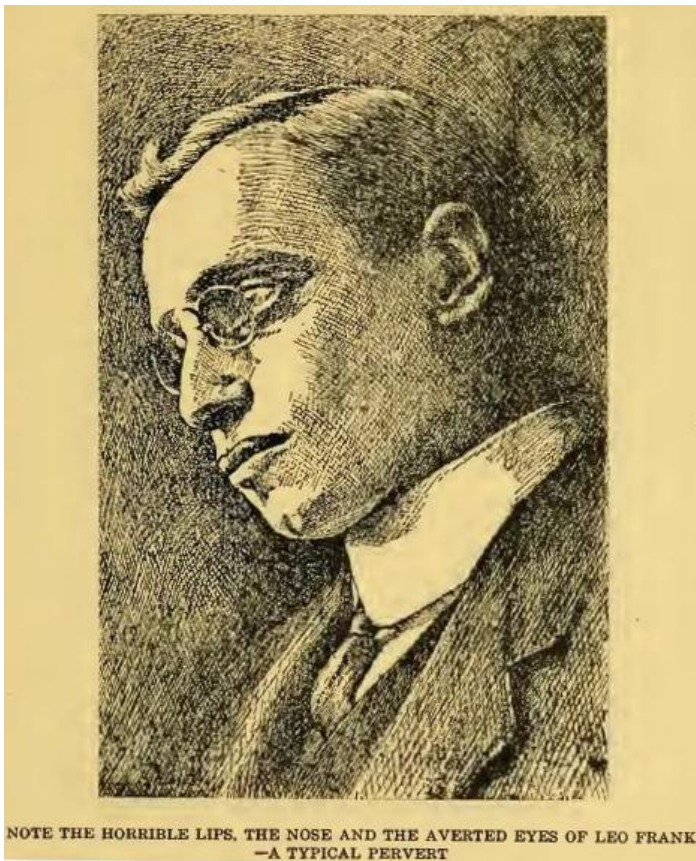

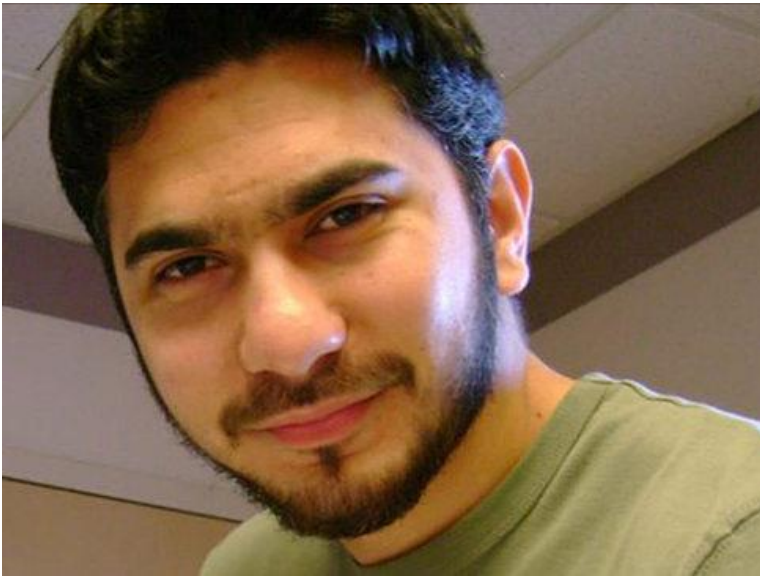

The study was published by Svante Pääbo in the prestigious journal *Science*, reversing Pääbo's own previous findings, which had asserted wrongly that neanderthals could not mate with modern humans and had gone extinct.

**The May 6, 2010 issue of *Science*,
Journal of the American Academy
of Sciences, has finally confirmed
that modern human populations
have significant Neanderthal
genetic admixture. This study by
the Max Planck Institute of Leipzig
under the overall leadership of Dr.
Svante Paabo but also included
some researchers from the
Harvard University School of
Medicine.**

Behind the scenes, it seems that this DNA study's dramatic reversal of the Paabo-Stoneking *Cell* article of July 15, 1997 insisting that there was *no* Neanderthal DNA in modern humans was due to the fact that Harvard researchers came up

with data that contradicted the 1997 study by Svante Paabo (then at the University of Munich) and Mike Stoneking (then at the University of Pennsylvania).

Personally, I have always suspected that this 1997 study was purposefully concocted or even commissioned to please North American Jews and to further Israeli interests. In the 1997 study, Svante Paabo and Mike Stoneking claimed to have re-created part of the Neanderthal DNA sequence to an “acceptable” extent (2%) and then to have compared it to human DNA (but the complete human genome wasn’t mapped until 2005). In short, Paabo and Stoneking were comparing nothing to nothing. Dr. Alan Templeton, a geneticist at the American University in St. Louis, characterized their 1997 study as “a statistical house of cards.”

At that time the acknowledged world expert on Neanderthals was Dr. Erik Trinkaus, formerly of the Anthropology Department at the University of New Mexico. His massive book ***The Neandertals*** was published in 1992 (Random House, and in two revised Vintage “University Format” paperback editions 1994-1996). Trinkaus chose to adopt the new German spelling system which hasn’t caught on among Germans. ***The Neandertals*** contained this observation in the concluding pages (March, 1994 Vintage paperback): “Only humans from the Near East and parts of Europe can claim Neandertals per se in their *direct* ancestry” (page 416, my emphasis). The 1997 Paabo-Stoneking study published in the July issue of ***Cell*** was highly promoted in North American media, contradicted Trinkaus, prevented Random House from issuing a cheaper mass-market paperback edition of ***The Neandertals*** in the Fall of 1997 and immediately enthroned Svante Paabo instead of Erik Trinkaus as the world’s leading expert on Neanderthals in the public mind. Naturally, the 1997 Paabo-Stoneking ***Cell*** article also discredited my own books ***The Iceman Inheritance*** (1978) and ***Chosen People from the Caucasus*** (1992) because I had concluded exactly what Trinkaus had concluded, only I said it first. This new May 2010 study concedes that from “1 to 4” percent of modern human DNA is Neanderthal. However, I see and smell a little loophole just large enough for a statistical rat.

The conclusions of this new 2010 study, certainly vetted and possibly written by Paabo, are clearly intended to convey the impression that this “1 to 4 percent” of lingering Neanderthal DNA is more or less evenly distributed throughout the world except for Africa where there is supposedly *no* Neanderthal DNA — and I find this hard to believe.

The May 2010 study even found Neanderthal DNA in New Guinea, which *is* highly unlikely and I wonder who the carefully chosen modern donor was to get this supposed Neanderthal DNA. I like to joke that it was probably the fictional (I hope) Dr. Jacob Epstein, formerly a New York doctor who now practices in Port Moresby. That’s the worldwide “Paabo spin” on Neanderthal DNA in modern humans and, looked at this way, “1 to 4 percent” doesn’t amount to much. Figures don’t lie but liars figure.

There is, however, *another* way of looking at this “1 to 4 percent” of Neanderthal DNA in modern humans. What if this Neanderthal DNA is concentrated in the Caucasus Middle East, where this 2010 study admits that Neanderthals and Cro-Magnons (or “Early Modern Humans”) met and interbred? Surely it is reasonable to suppose that the main concentration of the world’s surviving Neanderthal DNA must be in *this* area, *discounting very modern migrations of some people by railway, steamship and aircraft transportation*, and that Neanderthal DNA decreases rapidly as distance from the Caucasus centre of interbreeding increases?

There would be virtually no Neanderthal DNA in Atlantic Western Europe, but there would be more in Central Europe and much more in Eastern Europe, *and especially in mountainous areas*. There would be virtually none northward toward the Baltic Sea and virtually none east of Khazakhstan to Pacific Far East Asia. And we were already told that there is supposedly *no* Neanderthal DNA in Africa. But actually there *should* be at least *some* Neanderthal DNA in North Africa because the Arab-Muslims conquered it. Now, *this* sort of Neanderthal DNA distribution might *average out* to that insignificant “1 to 4 percent of Neanderthal DNA in the whole world’s population.” See? As Mark Twain put it: first come lies,

then damn lies and then statistics.

Now, assuming *this* sort of concentration of Neanderthal DNA in the Caucasus Middle East, that “1 to 4” percent of world population suddenly becomes *very* significant indeed. It means that **the Semitic peoples of the Middle East — Jews, Arabs and others (like Armenians) — must, therefore, be substantially Neanderthal.**

And *this* sort of concentration of Neanderthal DNA seems to be the case.

On May 10, 2010 a Svante Paabo co-researcher on the new study, Johannes Krause, said on the Mid-German TV Network that the people of the Middle East, the Semites, were at least from “10 to 20” percent Neanderthal. The Internet link to this interview on the Mid-German TV Network was deactivated on May 18, 2010.

This is *precisely* what I argued in *The Iceman Inheritance* (1978), *Chosen People from the Caucasus* (1992) and what Erik Trinkaus at least inferred in his *The Neandertals* of 1992. However, **my own calculations indicate that some Middle East Semitic populations approach 50 percent Neanderthal and in some very specific small areas, 70 percent Neanderthal.** Given the usually modest Semitic populations in mountain valleys and arid landscapes of the Caucasus Middle East, this sort of Neanderthal DNA concentration among some groups would not affect that “1 to 4 percent” of the total world population very much.

In my view, there are two major subspecies of *technical* “humanity” presently contending for the domination of our world.

One subspecies and the most influential one in terms of its sheer numbers and geographic extent can simply be called “ordinary humanity”. Before 15th century European maritime expansion and commerce they inhabited Atlantic Western Europe, most of Africa, perhaps “Atlantis” in the past, North and South America and across the Pacific to the Far East, Japan and China. There are several geographic varieties of this

subspecies differentiated mostly by skin colour and some other physical traits, but this subspecies as a whole exhibits a clear tendency toward **polytheism, a tolerance of females in society and in divine affairs and a relatively low level of aggression**. All varieties share a reasonable level of intelligence, very definite visual artistic ability, *relatively* non-protruding noses and only moderate male hairiness. Because of the differences in physical characteristics of this subspecies, it *may* be possible that it really consists of several subspecies that evolved separately in slightly different ways within their various geographic areas and different environments of origin. Or, it *may* have originally been just one Eastern or Southern African subspecies that migrated into various geographic areas and *then* evolved unique characteristics. This latter is the modern view, but it may not be correct.

However, the roughly common *mentality* of this subspecies, much more important than its superficial physical differences, indicates a relatively low degree of sexual dimorphism in its primal anthropological ancestry – *except in areas where it has since been greatly affected biologically and culturally by the expansion of the other contending subspecies*, as in Central and Western Europe after the Jewish Diaspora of AD 70, the Hun invasion AD 451-453 and Khazar migrations from the Russian-Ukrainian steppes into Central Europe of circa AD 1000 to 1300.

This other contending subspecies originated in what I call the “Toxic Lozenge”, a narrow elongated area extending from the Rift Valley lakes of Tanzania, Kenya and southern Ethiopia to the northern Caucasus Mountains. This Toxic Lozenge therefore encompasses the geographic epicentres of both *Homo habilis* and later Neanderthal development. This Toxic Lozenge is *also* the original homeland of the Hamitic languages and the later seemingly related Semitic ones.



Note that Ancient Egypt was well to the west of where this Toxic Lozenge crosses the Red Sea between Jiddah and Medina in Arabia – an area now called Hijaz and/or Yemen but known as Saba (biblical “Sheba”) in ancient times – the very place where the first evidence of the Hebrew language has been discovered and where Islam was also later conceived (see *Queen of Sheba and Biblical Scholarship* by Dr. Bernard Leeman much further down on this website).

Physically, this subspecies is characterized by **very great nasal development, extreme hairiness in males, long torsos and short legs, extremely high numerical and spatial intelligence, very little visual artistic ability, a low level of emotional stability, fanatical monotheism, anti-feminism and a predisposition to control, enslave or exterminate “ordinary humanity”**. There is some anthropological evidence that this subspecies may derive from *Homo habilis*, through the Neanderthals and on to modern representatives. However, not all anthropologists agree that *Homo habilis* should be considered fully “human” as that term is rather loosely defined, but was possibly an aberrant offshoot of either *Homo* or *Australopithecus* (see *Esau’s Empire I* on this website). That is, people deriving from this Toxic Lozenge in ancient times may not be *exactly* human and certainly seem to be incompatible with the values and attitudes of “ordinary humanity”. However, recent historical migrants into the Toxic Lozenge represent mostly ordinary African humanity.

Much more important than physical traits, the aggression of this subspecies is responsible for its expansion from its original Toxic Lozenge both east and west to inhabit most of the “Middle East” (especially mountainous regions) and even parts of Europe, western India and northern and eastern Africa, imposing its religious and social values. In short, the people of this Toxic Lozenge have gradually driven a wedge of perhaps “not-quite-human” genes and culture between the ordinary humanity of the West and the ordinary humanity of the Far East. And this wedge has been inexorably expanded by well known historical events from 5600 BC to the present. Despite the incessant propaganda and disinformation promulgated by this subspecies, adherence to Judaism, Judeo-

Christianity and Judeo-Islam are *the* symptomatic indications of its biological expansion and/or cultural influence.

This Toxic Lozenge subspecies is the most influential one in terms of its extremely high aggression (see "Hard Times Among the Neanderthals", *Natural History, the Journal of the American Museum of Natural History*, New York, December 1978 by Dr. Erik Trinkaus and Dr. T. Dale Stewart of the Smithsonian Institute).

How aggressive are they? Trinkaus and Stewart subjected every Neanderthal bone then known to a forensic-style analysis and found ***over twice the number of violence-inflicted injuries as among any similar number of bones from other fossil humans.*** Nonetheless, though extremely violent, Neanderthals took care of their injured and elderly people (Trinkaus and Stewart; see also Ralph Solecki's later work at Shanidar cave). Ironically, this Trinkaus and Stewart article was published one month *after* the publication of ***The Iceman Inheritance*** in November, 1978. I could certainly have used this data if it had been available a few months earlier.

This December 1978 Trinkaus-Stewart study and article adequately explains why the Middle East has been a region of chronic conflict for about 3,500 years of more or less reliably recorded human history. Very little more needs to be said or written about extreme Middle Eastern aggression itself.

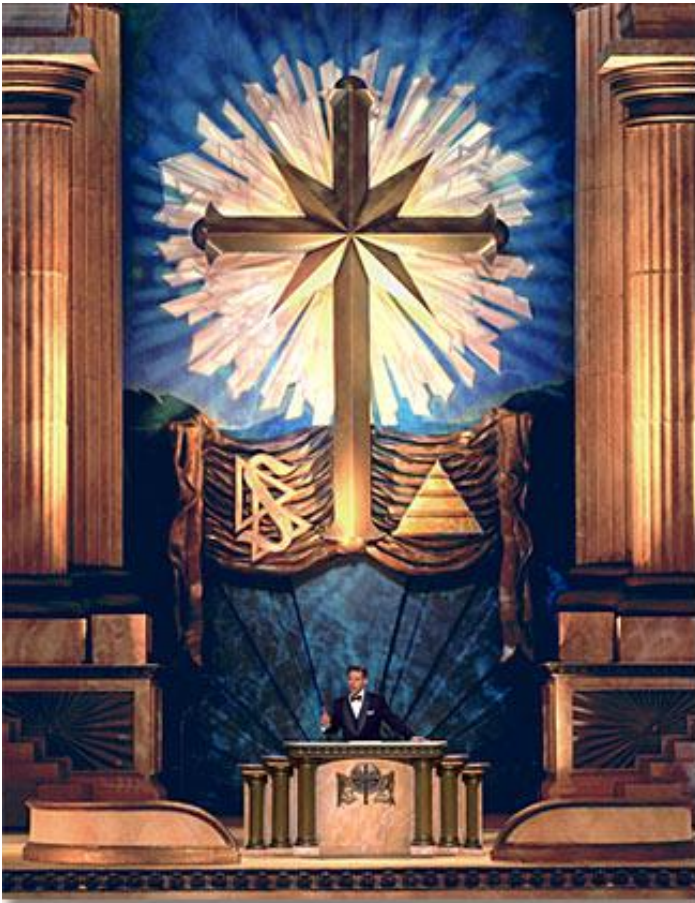

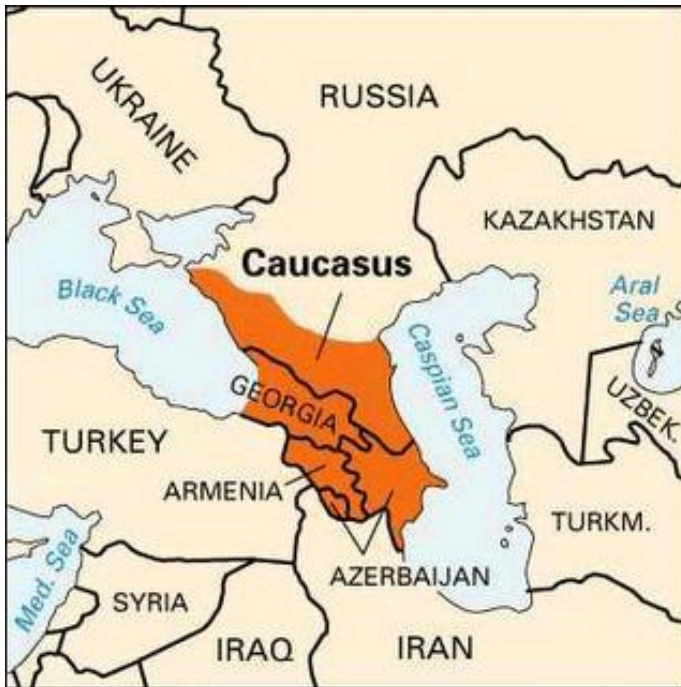


In Michael Bradley's BRILLIANT 1992 book *Chosen People from the Caucasus* (subtitled *Jewish Origins, Delusions, Deceptions and Historical Role in the Slave Trade, Genocide and Cultural Colonization*) the author makes it crystal-clear that he, a half-jew himself, also sees the jews as genetic quasi-Neanderthals, but he interprets this in a **very negative light** — seeing jews as the **vicious, psychopathic, brutal** descendants of equally **vicious, psychopathic, brutal** Neanderthals.

Bradley posited that because Neanderthals were unattractive to white Cro-Magnons, and in fact their hooked nose looked sinister to them, virtually all interbreeding was by rape. The Neanderthals were perhaps shorter than Cro-Magnons (this is uncertain) but they were physically very powerful and with a large brain. They were not stupid, but likely inflexible and less creative and innovative than Cro-Magnons.

Modern Arabs and Jews would then inherit these traits, yet they of course also have Cro-Magnon ("European" blood as well.. They are Cro-Magnons with LOTS of Neander blood and we are Cro-Magnons with **very little** Neander blood. Dear All:

As everyone in the Western world must know by now, Svante Paabo was born in Stockholm, Sweden and went to Uppsala University. His father, Sune Bergstrom, was a Nobel Prize co-winner. His mother Karin Paabo is Estonian and apparently (according to a television interview I saw in 1997) Jewish. Since Jewishness supposedly passes through the mother, that makes Svante Paabo "Jewish" too. He at least **adopted her name** rather than his father's name, perhaps because he wanted his own career and wished to distance himself from a former Nobel Prize winner. He was one of *Time* magazine's "World's 100 Most Influential People" sometime in the 1990s. In an email to John de Nugent I called Paabo "a Jewish spin doctor" on the basis of the interview I saw because of his 1997 *Cell* article with Mark Stoneking of the University of Pennsylvania, in which they claimed to have reproduced Neanderthal DNA "statistically" to an "acceptable" (2%) degree and compared it with human DNA (but the entire human genome wasn't mapped until 2005).

In short, Pääbo and Stoneking were comparing nothing with nothing. American University (St. Louis) geneticist Alan Templeton called the 1997 *Cell* study "a statistical house of cards."

And the world's (then) leading expert on Neanderthals, Eric Trinkaus, dismissed the study because he had already written in the conclusion to his 1996 book *The Neandertals* (Random House) something like "only people from the Middle East and parts of Central Europe can boast Neanderthals in their direct ancestry." (my emphasis).

However, the Paabo/Stoneking results in the 1997 *Cell* article received massive favourable coverage in the popular North American press at the time. This prevented Random House from publishing a cheap paperback edition of Trinkaus's *The Neandertals*, which was, perhaps, the whole intention of the 1997 *Cell* article.

[JdN: *aand Cell* are the most prestigious science magazines in the world. I taught American accent (1996-2004) to many

Japanese scientists affiliated in Boston with Harvard and MIT, and it was their dream, or past achievement, to be published in one of the Big Three.]

It also enthroned Svante Paabo instead of Trinkaus as “the world’s leading expert on Neanderthals.” The 1997 *Cell* article also helped to discredit my *The Iceman Inheritance* (1978) and *Chosen People from the Caucasus* (1991) where I said exactly what Trinkaus said, only I said it first.

Now, this newest 2010 study on Neanderthal DNA, published in *Science* on May 6, contradicts the 1997 *Cell* pronouncement mainly because Pääbo’s team included researchers from the Harvard Medical School who came up with different results than the concocted but highly-popular-among-Jews 1997 *Cell* article.

Nonetheless, I just suspected that Paabo would try to present the statistics in a misleading way by inferring that the “1-to-4 percent” of Neanderthal DNA in the human genome was **sprinkled evenly among the world’s total human DNA** (except in Africa where there is supposedly no Neanderthal DNA).

It makes more sense for this Neanderthal DNA to be concentrated in the Caucasus-Middle East [region], **where the Neanderthals and Cro-Magnons met and mingled**, and to taper off rapidly from the Caucasus Mountains interbreeding epicenter so that there is **virtually no Neanderthal DNA** in Atlantic Europe, the Baltic and the Pacific Far East.

I suspect that the New Guinea Neanderthal DNA came from a very carefully chosen subject of very recent Eurasian origin. This more reasonable distribution might “average out” to “between 1 and 4 percent” of the world’s total human DNA but it would mean at the same time that **all living Semitic peoples are substantially Neanderthal.**

On May 10, 2010 a member of Pääbo’s team, Johannes Krause, said on the Mid-German TV network [*Mitteldeutscher Rundfunk*] that Middle Eastern people carried “10 to 20 percent” Neanderthal DNA. I personally think it must be nearer to 40% Neanderthal DNA in some ethnic and national groups of Caucasus Mountain origin.

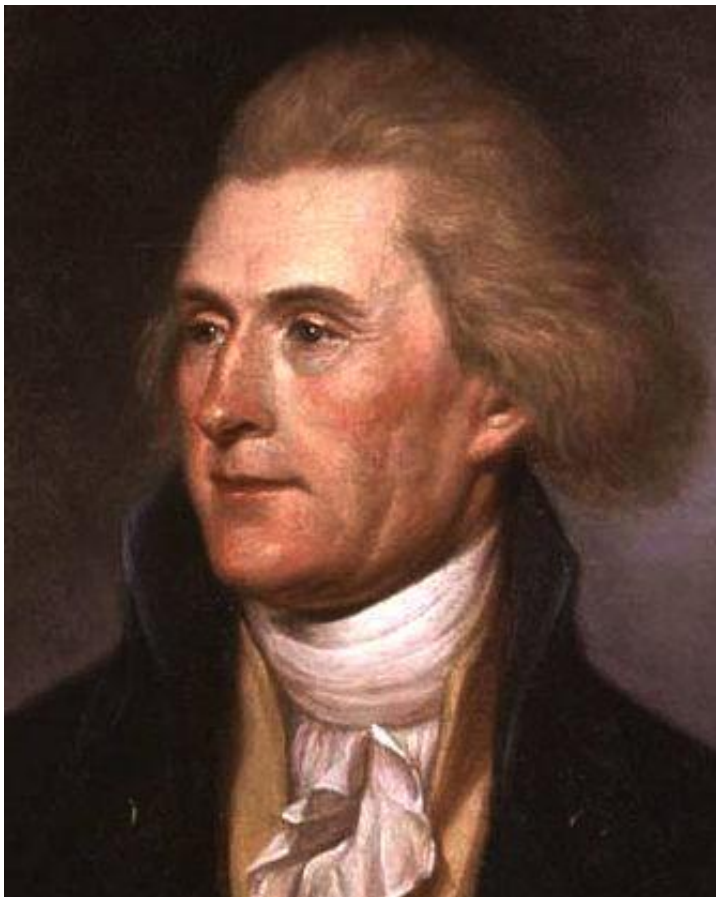

.....WHEN NEANDERTHALS BECAME HEBREWS

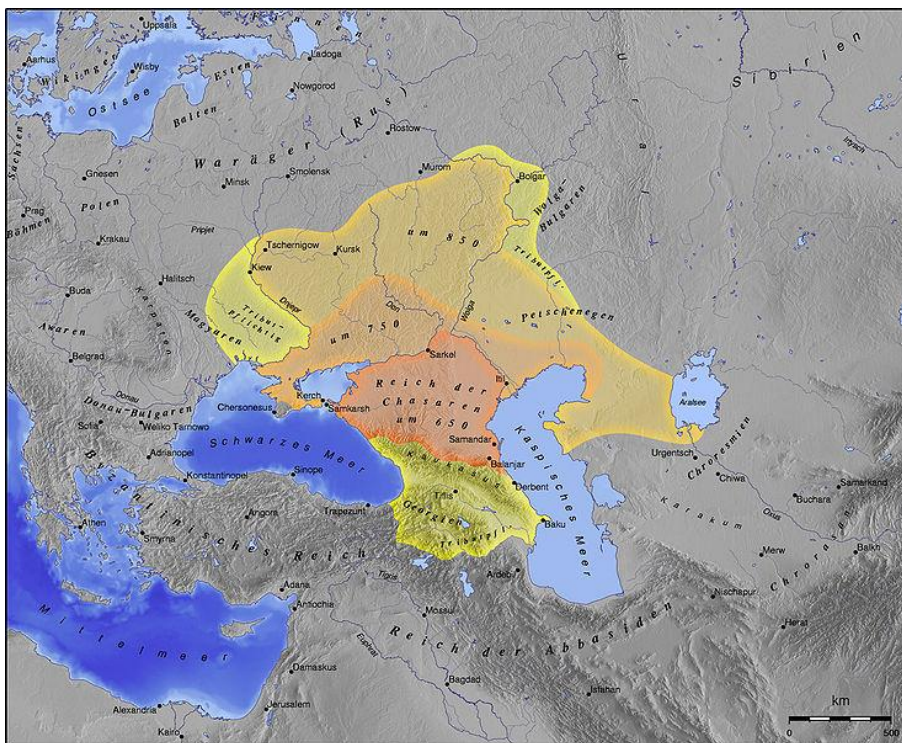
I often call these Jews simply **juze** to show the **entity-like nature** of their swarming behavior. 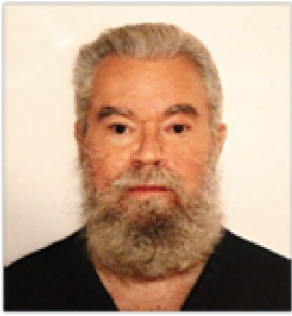

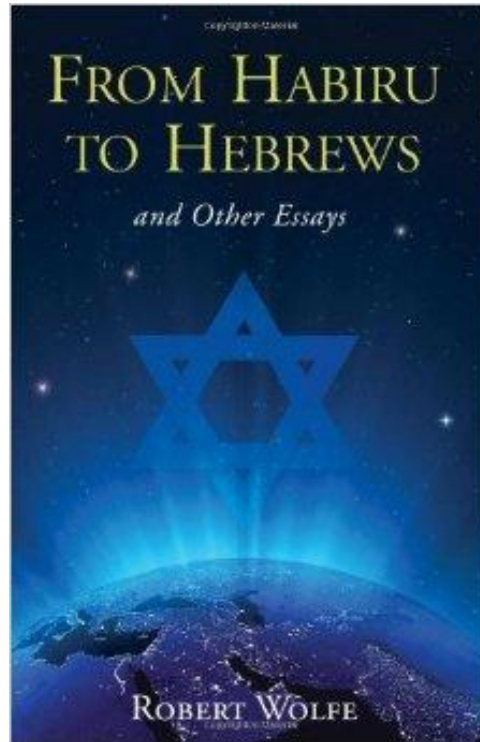

come from a secular Jewish background, the son of **Jewish parents who belonged to the Communist Party during the 1930s**. They left the Party in 1939, around the time of the Nazi-Soviet Pact, and also left each other, getting divorced when I was about two years old. I was raised in the home of my mother in Washington Heights, a neighborhood in Manhattan which at that time was about half Jewish. Most of my boyhood friends were Jewish, and so too were most of my mother's friends, who tended to the same "progressive" point of view as she did. My father too remained a "progressive", meaning someone who agreed with many of the positions of the Communist Party without necessarily belonging to it. So from an early age I received a heavy dose of Jewish secular culture along with a sense of identification with the progressive current in American life.

By the time that I graduated from college in 1958, that current had been very much submerged by the anti-Communism of the 1950s. I decided to go to graduate school and was fortunate enough to be admitted to the history program at **Harvard** University with a Woodrow Wilson scholarship. I formed the resolve to specialize in the study of revolutions and wrote my PhD thesis on the subject of the popular organizations in the Paris Commune of 1871. In 1965 I got a job teaching history at the Washington Square College of New York University, but unfortunately for me, **I was even more interested in making revolutions** than I was in teaching about them. My involvement with the radical student movement at

NYU led eventually to my participation in the spring of 1970 in the student takeover of the Courant Institute at NYU, a building which housed a huge computer belonging to the Atomic Energy Commission. To make a long story short, I ended up fired from my job at NYU and sentenced to **three months in prison** for helping to hold the computer for ransom.

The Hebrews

What was the precise meaning of the term, "Habiru," in its original context? And for that matter, was the term actually "Habiru," or rather "Apiru"? These questions need to be answered in order to address the larger question of the relationship between the terms "Habiru" and "Hebrew."

For many decades after the tablets from Tell el-Amarna and elsewhere were first unearthed, no one doubted that they made reference to people called "Habiru." In the English language translation of the Tell el-Amarna tablets published by Samuel Mercer in 1939,



the term "Habiru" is used without any hint of the possibility of a different reading. By the way, in an "Excursus" at the end of the book, on page 843, F. H. Hallock stated:

But we must admit some association between Hebrews and Habiru; linguistic and historical considerations make this inevitable, even though in the light of present-day knowledge we cannot speak with too great certainty concerning that association.
.

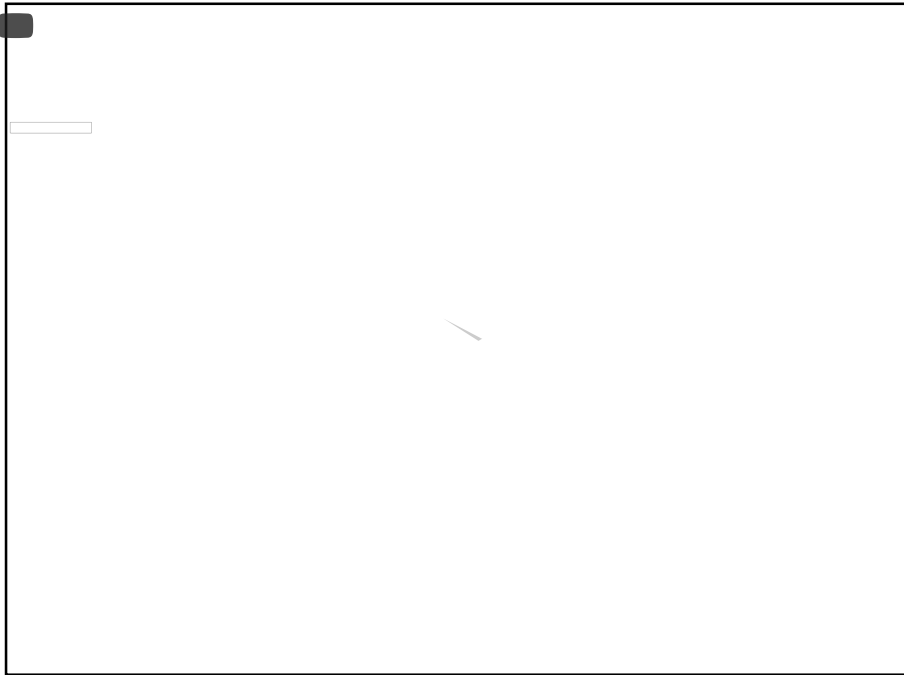
Biblical scholars are generally agreed as to who the Habiru were, but there is a certain range of opinion as to how they were perceived. Bottero thought “refugee” was the most accurate term, while Weippert preferred “**outlaw.**” The one trait that defined the Habiru as a group is that they **stood outside the established social order both literally - they camped on the outskirts of the settled areas - and figuratively.**



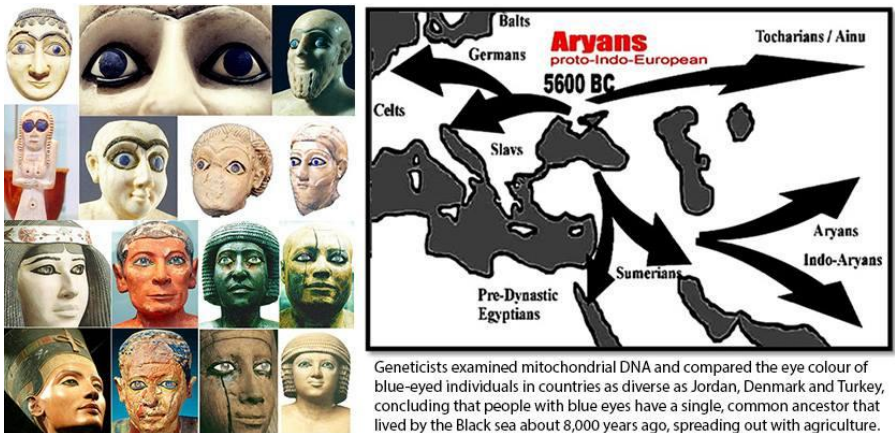
But there were evidently degrees of difference from one place to another as to how **antagonistic** was their relationship to that order. If they served as mercenaries, they might have a relationship to the state that was defined by some kind of formal agreement. Some Biblical scholars believe that they were generally seen as “**foreigners,**” whereas others emphasize their status as “fugitives.” There is no obvious reason for preferring one term over another, since all of them undoubtedly have some basis in fact.

However, a clue to how the term “Habiru” was generally understood in the 2nd millennium BCE is provided by the existence of similar terms in other Middle Eastern languages. In particular there is the Sumerian expression, “**SA.GAZ**”. I don’t know enough about Sumerian hieroglyphics to understand why it is written this way, but since that is how most Biblical scholars write it, I am following suit. The Sumerians were a people whose ethnic and linguistic background is not well understood and who were settled in the southern part of what is now Iraq by the time that they developed a hieroglyphic writing system around 3000 BCE.

The Accadian writing system was derived from the Sumerian and it also took over the Sumerian term "SA.GAZ", which was widely used in Accadian texts, including the Tell el-Amarna tablets, as a synonym for "Habiru." Bottero, on page 82, notes that the two terms were used alternately in texts unearthed at Boghazkoy, the capital of the Hittite empire in what is now Turkey, and the Biblical scholars all agree that the meaning of the two terms was more or less identical. According to Bottero, on page 149, the root meaning of SA.GAZ in its original Sumerian context "is pejorative and indicates a **violent and criminal act of aggression, and most often the perpetrator of that aggression**" [my translation].

Hence Bottero thought that "SA.GAZ" should be translated as **"brigand"** despite the fact that he also thought that "refugee" was the best translation for "Habiru." But this contradiction is more apparent than real, for it would appear that the Habiru were **refugees (or fugitives) who became brigands.**



This is precisely the conclusion suggested by an article by Nadav Na'aman, "Habiru-like Bands in the Assyrian Empire and Bands in Biblical Historiography", appearing in Volume 1 of his *Collected Essays*. In Assyrian inscriptions dating from the 7th and 8th centuries BCE there are references to a group called "urbi" in the Assyrian language. The meaning of the term has been variously given as **"fugitives," "bandits," "irregular troops," "a special type of soldiery" or "elite troops."** According to Na'aman, the term "urbi" was derived from a verb, **"merubu", which meant "to flee, run away, escape."** Na'aman continued as follows, on page 299:

The term *urbi* refers to groups of fugitives who, in the face of Assyrian military campaigns, destructions or annexations, fled from their homeland and found shelter in peripheral areas. These uprooted people tried to adapt themselves to new circumstances by forming a band under the command of a prominent leader. The bands were independent armed bodies, restricted in number and characterized by their **predatory nature and military ability. Often they became dangerous to sedentary and pastoral societies.** Thanks to their military ability they served on occasion as mercenaries in the armies of neighboring rulers.

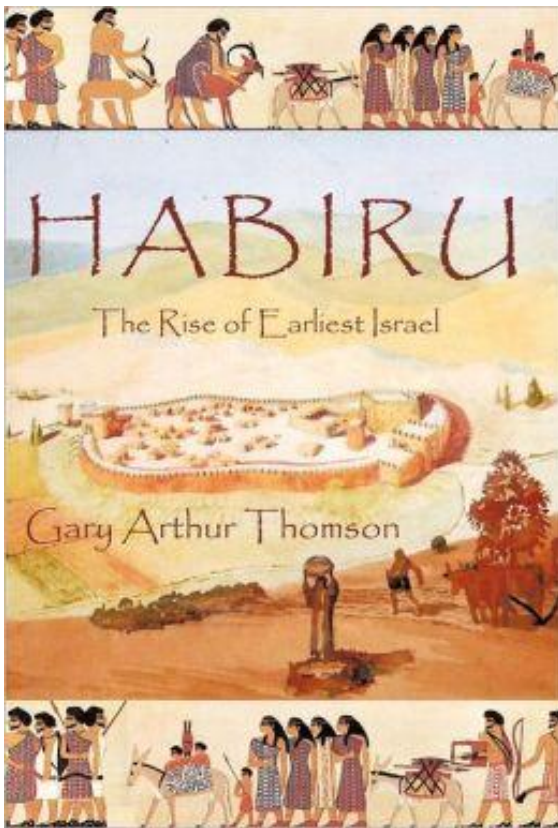

And Na’aman concludes: “**All of these characteristics are typical of the bands of Habiru**, which are so well known from late third- and second-millennium BCE ancient Near Eastern documents.” The important point which emerges from all this is that for the people who wrote and read the texts in which terms like “SA.GAZ” or “Habiru” or “urbi” appear, **all of these terms must have had a negative connotation**. Sometimes this connotation became explicit, as in one of the Tell el-Amarna letters, appearing on page 261 of Mercer’s translation, where one Canaanite official says of another that he has become just like the SA.GAZ people, “a runaway dog.” The Habiru were outlaws by definition since they did not form a part of the established social system and did not consider themselves bound by its laws.

Furthermore, the fact that many of them were fugitive slaves added an additional element of criminality to their image, since in all slave holding societies, flight from slavery is considered a serious crime, often punishable by death. To be sure, the Habiru also had the image of constituting a serious military force, but while this might have endeared them to some, for the established social order it was probably just



another count in the indictment. Whether the Habiru themselves felt proud of their outlaw status is hard to say, but the weight of the evidence indicates that proud or not, they were eager to get rid of it.

The best way of finding out how the Habiru felt about being called “Habiru” is by examining how the Hebrews felt about

being called “Hebrew.” All the texts which mention the Habiru were written by others and therefore don't reflect a Habiru point of view, but the Hebrews had ample opportunity to make their views known. And the first thing which every Biblical scholar has noticed about the way the term “Hebrew” is used in Tanach is that it is hardly used at all. In the whole of Tanach, the term “Hebrew” appears only 33 times. In the Torah, the Hebrews are almost always described as the “sons of Israel” (“b'nei Israel” in Hebrew, usually translated as “children of Israel” or “Israelites”). In the later books of Tanach other terms are used, but hardly ever “Hebrew.”

Moreover, when the term “Hebrew” does appear, it is used in certain specific ways. Nadav Na'aman has probed this issue in depth in his illuminating essay, “Habiru and Hebrews: The Transfer of a Social Term to the Literary Sphere,” appearing in Volume 2 of his *Collected Essays*. **Like most Biblical scholars, Na'aman doesn't think that the Hebrews were Habiru, but he has no doubt that the term “Hebrew” was derived from “Habiru.”** He points out, on page 270, that in Tanach, the term “Hebrew” is typically used to describe “Israelites in exceptional circumstances.” In particular it is used to describe “Israelites

migrating to a foreign country” or “Israelites in a position of slavery.” He adds that the use of the term “Hebrew” is especially prevalent “in the stories of the book of Exodus, in which it is applied to Israelites who were enslaved and exploited by the Egyptians for hard labor.” And he concludes, on page 271: “It seems clear that all biblical references to the ‘Hebrews’ reflect some traits borrowed from the image of the second millenium Habiru.”

A good example of the way the term “Hebrew” is used in Tanach may be found in Chapter 29 of the *First Book of Samuel*. After being forced to flee from the territory of “Israel” because of the wrath of king Saul, **the future king David has gathered a band of malcontents around him and found refuge among the Philistines**. Now the Philistines are preparing for battle with the forces of king Saul, and David and his band are ready to join them. But the “princes of the Philistines” cry out: **“What do these Hebrews here?” Achish, David’s protector among the Philistines, is compelled to send David and his men away, because the other Philistine leaders do not trust him and fear he will join forces with king Saul when the battle is imminent.**

The use of the term “Hebrews” in this context may of course be understood as a reference to the ethnic group of which David and his men were members; but it also makes perfect sense as a synonym for “Habiru”, implying a **ragged band of mercenaries viewed with disdain** by most of the Philistine leaders. It would seem that the authors of Tanach could not help but make occasional use of the term “Hebrew” as a way of adding a note of realism to their story, while at the same time systematically avoiding any explicit identification of the Hebrews as Habiru because it would have conflicted with the legend of the “sons of Israel.”

And this dovetails exactly with what I wrote in this essay: <http://johndenugent.com/neanderthals-and-semites/> I found in Wikipedia articles on the *apiru* in English, German and in French, saying clearly that the people whom the Old Testament later on calls “the Jews” (and earlier on called the

“Hebrews”) are likely the descendants of the *Habirus* — and these Habirus or *apirus* were in actuality a **gang of criminals wandering around in the Middle East, outlaws**, a horde which already 4,000 years ago was annoying the leaders of the Sumerian empire, and of the Hittite, Egyptian and Assyrian civilizations.

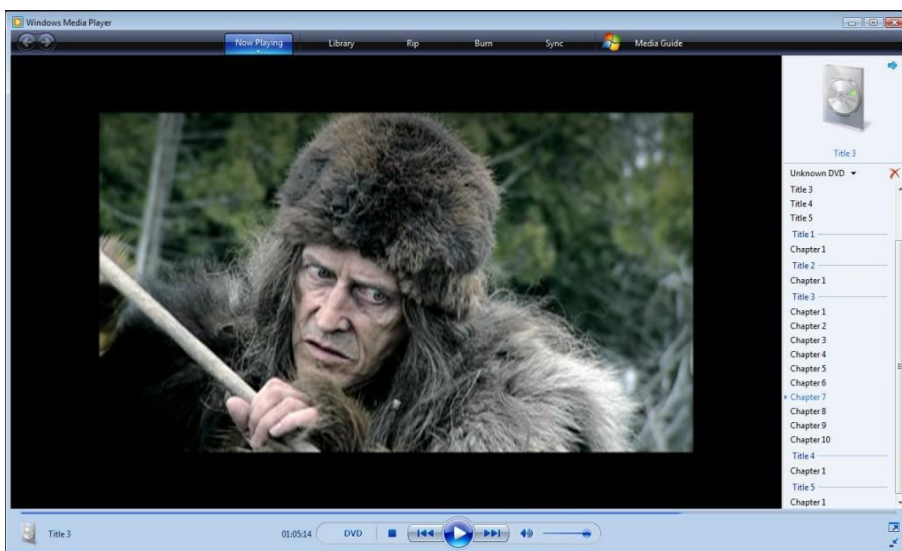

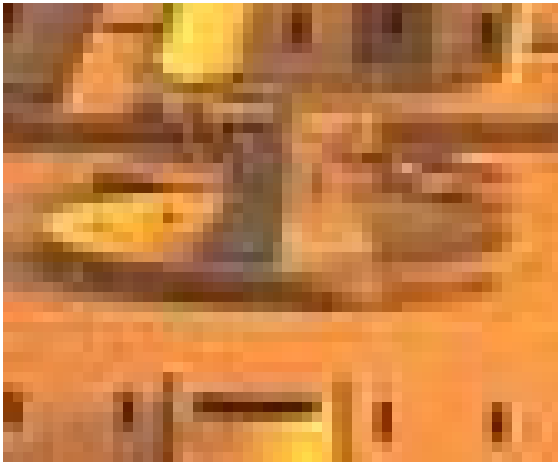

In medieval Germany **the forest** (as in this depiction of the fairy tale) meant a place **women and girls would not walk through alone**, whether due to animal wolves or human wolves. In fact, as late as the 1700s there were many still *apiru* (jewish) criminals, highwaymen, lurking in the forests of southern Germany. The story of Little Red Riding Hood reflects this fear of HUMAN stranger-danger in the forest.



And antisocial females would join them ... or normal women would be abducted so the sociopathic clan had females for sex and cooking.

And this union produced babies ...

Then an entire tribe ... then a whole “people” ...or anti-people.

To designate the southern Italian Mafia in the United States, we often use the term “**crime family.**” This expresses that the various mafias are more than mere “companies” or “organizations.” They are real **clans, bands of people,** united by feelings of belonging and by ties of marriage, blood and/or friendship as well as by greed and self-interest. They are “fraternal” organizations of an evilk sort, exhibiting a sordid solidarity (aside from the occasional assassinations among the leaders 😏).

My volunteer from New Zealand, Nelson1805 (whose writings I often have featured on this blog) has described in a brilliant report to me the Khazars — the ancestors of 90 percent of Jews today — and how he traced the Khazar aristocracy back to the Scythians, a largely white, Old Iranian and blond tribe of **barbaric psychopaths.**

(As Wikipedia reveals, the **lower-class** Khazars were **swarthy** Caucasoids who were genetically like the Armenians, Chechens, and Georgians of today, such as the Georgian mega-psychopath Joseph Stalin).

These Scythians were a horrible, savage and barbaric horde, white though they were. They were **Aryan psychopaths**, roaming around what is now Ukraine, and a tribe that the ancient Greek historian Herodotus denounced for their **cruelty**.

We can safely extrapolate from the movie "Ice Age Columbus" that for thousands of years various **exiled or escaped individuals** since at least the Ice Age have been forming **clans of criminals**, and I believe, based on my research into the *apiru*, that exactly this kind of criminal outlaw clan was at the origin of the Jews, and of the Scythians, who later were known

as Khazars and became converted to Judaism.

(The word "outlaw," btw, does not just mean just "criminal." Sephardic leader Yosef: Non-Jews exist to serve Jews

JERUSALEM (JTA [JEWISH TELEGRAPH AGENCY]) Israeli Sephardic leader Rabbi Ovadia Yosef in his weekly Saturday night sermon said that non-Jews exist to serve Jews.

JERUSALEM (JTA [Jüdische Nachrichtenagentur]) Der Führer der sephardischen Juden, Rabbi Ovadia Yosef, sagte in seiner samstäglichen (Sabbat) Predigt, daß Nichtjuden existieren, um den Juden zu dienen.

“Goyim were born only to serve us. Without that, they have no place in the world; only to serve the People of Israel,” he said during a public discussion of what kind of work non-Jews are allowed to perform on Shabbat. *Die Goyim wurden dazu geboren, um uns zu dienen. Sie erfüllen keinen anderen Zweck auf dieser Welt, als dem Volk Israel zu dienen, sagte er während einer öffentlichen Diskussion, in der es darum ging, welche Arbeiten einem Nichtjuden erlaubt sind, sie am Shabbat zu verrichten.*

Why are gentiles needed? They will work, they will plow, they will reap. We will sit like an effendi [a Turkish pasha] and eat,” he said to some laughter. *Wozu werden die Nichtjuden gebraucht? Sie werden arbeiten, sie werden pflügen und sie werden ernten. Wir werden ihnen wie ein Effendi zusehen und essen,” sagte er unter dem Gelächter der Anwesenden.*

Yosef, the spiritual leader of the Shas Party and the former chief Sephardi rabbi of Israel, also said that the lives of non-Jews are protected in order to prevent financial loss to Jews. *Yosef, der geistige Führer der Shas-Partei [Koalitionspartner der Regierung Netanyahu] und ehemalige Chef-Rabbiner der Sepharden in Israel sagte auch, daß die Leben der Nichtjuden geschätzt sind, um die Juden vor finanziellen Verlusten zu schützen.*

“With gentiles, it will be like any person: They need to die, but God will give them longevity. Why? Imagine that one’s donkey would die, they’d lose their money. This is his servant. That’s why he gets a long life, to work well for this Jew,” said the rabbi, who recently turned 90. *Mit den*

Nichtjuden ist es wie mit jeder anderen Person auch. Sie müssen letztlich sterben. Aber Gott schenkt ihnen Langlebigkeit. Warum? Stellt euch vor, Jemandes Esel stirbt, er würde dadurch Geld verlieren. Der Esel ist schließlich sein Diener. Das ist der Grund, warum er [der Nichtjude] ein langes Leben hat, um für den Juden gut zu arbeiten," sagte der Rabbiner, der kürzlich 90 wurde.

An audio recording of some of the rabbi's remarks was broadcast on Israel's Channel 10. *Ein Audiomitschnitt einiger der Bemerkungen des Rabbiners wurde über Israels [Radio] Kanal 10 verbreitet.*

The American Jewish Committee condemned the rabbi's remarks in a statement issued Monday. *Das Amerikanische Jüdische Komitee [AJC] verurteilte die Bemerkungen des Rabbiners in einer am Montag veröffentlichten Erklärung.*

"Rabbi Yosef's remarks, suggesting outrageously that Jewish scripture asserts non-Jews exist to serve Jews, are abhorrent and an offense to human dignity and human equality," said AJC Executive Director David Harris. *"Rabbi Yosef's Bemerkungen, die auf shockierender Weise andeuten wollen, dass die jüdische Heilige Schrift behaupten würde, daß Nichtjuden nur existieren, um den Juden zu dienen, sind abscheulich und ein Verstoß gegen die menschliche Würde und menschliche Gleichheit," sagte AJC-Direktor David Harris.*

"Judaism first taught the world that all individuals are created in the divine image, which helped form the basis of our moral code. A rabbi should be the first, not the last, to reflect that bedrock teaching of our tradition." *Das Judentum brachte der Welt zuerst bei, daß alle Individuen als göttliche Abbildung geschaffen sind, was half, die Basis unserer moralischen Ordnung zu formen. Ein Rabbiner sollte der erste sein, diese Grundlagenlehre unserer Tradition zu reflektieren, nicht der letzte."*

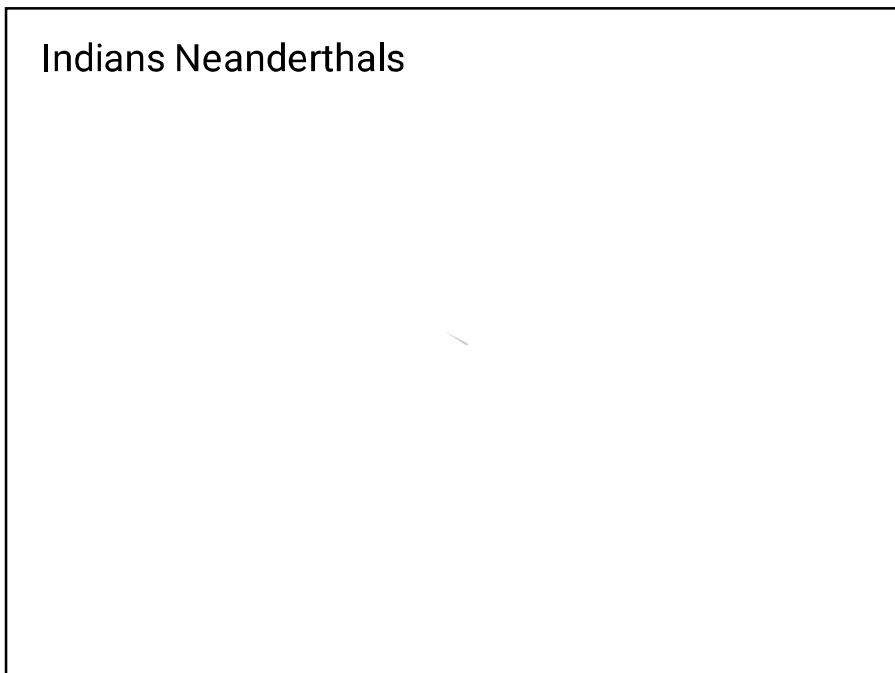
JdN: These denials are meaningless, because as Ralph Waldo Emerson once said to someone, Who you are speaks more loudly than what you say.
